The recruitment for this position is being done jointly between the Medical Center and its exclusive provider of pathology service, Consultants for Pathology and Laboratory Medicine (CPLM). The Department consists of divisions of Anatomic, Clinical and Experimental Pathology. There is an active residency program and 2 hematopathology and 1 molecular pathology fellowship positions. The ideal candidate will join our experience team which is engaged in the broad practice of hematopathology including morphologic and molecular hematopathology, flow cytometry and consultative coagulation.

Cedars-Sinai Medical Center is an 877 bed quaternary care medical center that includes the Samuel Oschin Comprehensive Cancer Center. Directions to the Moseley Salvatori Conference Center (Adjacent to the Good Samaritan Hospital)
